PTI, NEW DELHI: President Droupadi Murmu on Thursday said the mindset that bringing up children and managing home are the responsibility of women only has to change while noting that in spite of their increased participation they fail to make the cut above a certain level owing to family responsibilities.

keeping women at the centre, Murmu said this is the world's largest spiritual institution run by women and more than 46,000 sisters of this organisation are carrying forward the tradition of spirituality and Indian culture in about 140 countries. She said when women get equal opportunities, they perform on par with men and sometimes better than them in every field.

"She noted that women's participation is increasing in many fields. However, many of them are not able to reach the top position.
